## **ABSTRACT**

**Project Title:** Sustain to Succeed (S2S)

**Project Goals:** Lorain County Community College will expand opportunity and build institutional resilience by strengthening its dual enrollment program, expanding student access to the internet, and provide critical student support services for academic, social and career needs.

### **Project Outcomes:**

LCCC will accomplish the following project outcomes:

- Strategy 1: 25 high school faculty per year certified in dual enrollment
- Strategy 2: Create a plan to increase dual enrollment courses offered online
- Strategy 3: 400 laptops and hotspots distributed to students in need
- Strategy 4: 100 Fast Track students per year will receive tuition to earn short-term certificates

**Population to be served:** LCCC anticipates serving up to 650 students and faculty during the grant period. The strategies and activities of the S2S program will serve high school dual enrollment students in two urban high schools and seven rural high schools; and post-secondary students earning short-term certificates in the Fast Track program from urban and rural areas.

**Collaborative Partners:** To achieve the above strategies, LCCC will collaborate with regional dual-enrollment high school partners, LCCC's Early College High School, and numerous community organizations working with underserved populations, including Educational Service Center of Lorain Co., Lorain Co. Urban League, El Centro de Servicios Sociales, First Community Interfaith Institute, Boys and Girls Club of Lorain Co., Lorain Co. Community Action Agency, Ohio Means Jobs—American Jobs Ctr. (WIOA), Reentry Coalition of Lorain Co.
