Congresswoman Marcy Kaptur's Multiemployer Pension Legislative Activity

Following passage of the Multiemployer Pension Reform Act (MPRA) in the Cromnibus of 2014, Kaptur immediately set to work to learn MPRA's impact on retirees and correct the harm. In this review, the Keep Our Pension Promises Act (KOPPA) was developed; Senator Bernie Sanders' office was the Senate lead on companion legislation.

Keep Our Pension Promises Act- Protects retirees by restoring the ERISA's anti-cutback rule; strengthens multiemployer pension plans, including "orphaned" participants; provides additional funding by closing tax loopholes the wealthy use to accumulate expensive artwork and tax-advantaged savings, to protect retirees and the PBGC; ensures pension obligations are prioritized during bankruptcies

In June 2016, **Kaptur lead request to Government Accountability Office** (Brown lead Senate request) for a review internal decision-making of the Central States Pension Fund.

- GAO provided staff periodic updates on the report's progress, Aug 2016-Dec 2017.
- Report delayed upon discovery of additional materials, anticipated in winter 2018.
